Section 22-101 Definitions

- 1. **Building** means any type of building wether residential or commercial.
- 2. Street means any road highway or lane provided for transportation of the general public.
 - A. All streets maintained within the City limits of Bowman whether existing or hereinafter opened or developed within the City shall first be approved by the City council.
 - **B.** Each street shall be named and no street shall have a duplicate name or bear a name to close in similarity to the name of other existing streets.
 - C. Each street shall have a street sign erected at the corner indicating the name of the street.
 - D. Where a new street or portion thereof shall be a continuation or extension of an existing street, in that case the new street shall bear the same name as the existing street which is continued or extended.
- 3. Building Numbers. Every person owing any building fronting on any street within the City is required to have the entrance marked with a number to be assigned and designated by the building inspector or such other official as designated by the Mayor and Council of the City of Bowman, such number to be in accordance with a general system adopted with for the numbering of the building within the City by the Mayor and Council.
- 4. Penalty. This ordinance shall be enforced by the office of the building inspector for the City of Bowman and or the City Clerk. In the event the owner of a building fails to abide by the terms of this Ordinance then the City forces shall be entitled to affix numbers to the building and the owner of said building shall be liable for all costs in connection therewith for which execution against said property shall issue and the City shall be entitled to perfect a lien in accordance with the law of the State of Georgia.
